





- BJU's School for Continuing, Online and Professional Education (SCOPE) grew 45% and now has 2,000 students.





S&E Endowment Update

The Science & Engineering Endowment totals \$6,160,000. Of that total, \$120,588 came in this past fiscal year (6/1/2020 - 5/31/2021).

Our annual endowment spend amount is 4%.


This past year, the endowment funded these efforts:

- SITS (Summer Institute in Teaching Science) 2020 supported 14 faculty who developed or created 14 lecture or lab courses.
- SITS has four summers of faculty development tracks. Four new faculty completed their third track last summer.
- Science, religion and seminary faculty members collaborated to present five afternoons of worldview sessions.
- Six undergraduate students were funded in 2020 to do biology or chemistry research for eight weeks each through the RIU (Research Immersion for Undergraduates) program.

Opportunity Scholars Program

In 2016, the Bridge Scholars Program was launched to assist American minority students, and in May of this year the first group of 12 students under the scholarship graduated from BJU. In October 2020, the Bridge Scholars Program was renamed the Opportunity Scholars Program, because at its very essence, it is about giving an opportunity to those who have not always had access to Christian higher education. Up to 45 students each year benefit from this program.





We celebrated a fall 2020 enrollment increase over 2019-2020 thanks in part to generous support for the COVID-19 Student Emergency Grant that provided additional assistance to every student who applied. It made a tremendous difference to families who were experiencing economic strains as they weathered the coronavirus storm. Thank you!

This year, every eligible student who applied for the grant received funding to offset the financial hardships caused by COVID-19. In total, 768 students received aid.

SHP Phase 2 Update

The Ribbon Cutting Ceremony for the SHP facility was August 10, 2020. The facility has served hundreds of students already. In summer 2021, we embarked on a Phase 2 of the School of Health Professions renovation. Additional space on the first floor of the Mack Building was turned into a second Nursing Skills Lab, providing 12 new beds. This provides greater opportunities for growth beyond our new cohort of 25 students.

Kevin Welch was a gifted and successful Christian businessman, consultant and subject matter expert in health insurance. He and his firm advised BJU on the complexities of its self-insured employee health plan over a 20-year period and were instrumental in saving BJU millions of dollars.

Kevin developed a strong bond with BJU over these years. He was a generous donor to his church, missionaries and faith-based ministries, including BJU, where he was a President's Society member.

God called Kevin home in 2019. Shortly before his passing, Kevin felt led to make BJU a beneficiary of his large estate. Part of his estate helped fund the School of Health Professions facility.
